The objects for which the Company is established are unrestricted and the Company shall have full power and authority to carry out any object not prohibited by the laws of the Cayman Islands. 4 The liability of each Member is limited to the amount unpaid on such Member's shares. 5

As the Cayman Islands are an overseas territory of the United Kingdom, the United Kingdom retains the right to extend certain legislative provisions to the Islands and this is done by Orders-in-Council (laws adopted) made under the royal prerogative. The addition of local statutes has, in many respects changed and modernized the common law.

Amendments to the Companies Law in 2018, mean that companies who keep their books of account outside of the Cayman Islands must now provide information on these annually, or with such other frequency prescribed, to its registered office in the Cayman Islands upon receipt of an order or notice by the Tax Information Authority.

Section 238 of the Companies Law (2020 Revision) (" section 238 ") provides an avenue through which shareholders of a merged or consolidated Cayman Islands company can apply to have the "fair value" of their shares determined by the Grand Court of the Cayman Islands (the " Court ").

The Cayman Foundation Company (the "Foundation Company") is governed by the Companies Law (2020 Revision) (the "Law") of the Cayman Islands except as specified in The Foundation Companies Law, 2017.The Foundation Company is a not for profit body corporate having separate legal personality and may be established for any lawful purpose including commercial and charitable purposes.
