The CBP Form 434, Certificate of Origin may cover a single importation of goods or multiple importations of identical goods. Certificates that cover multiple shipments are called blanket certificates and may apply to goods imported within any twelve-month period specified on the Certificate.

NAFTA - Certificate of Origin

The U.S. – Mexico – Canada Agreement (USMCA) does not require a specific certificate of origin form (CBP Form 434) as does the North American Free Trade Agreement (NAFTA). The CBP Form 434 is not mandatory under the USMCA. A claim for preferential treatment under the USMCA should contain nine minimum data elements.

NAFTA Certificate of Origin This is a trilaterally agreed upon form used by Canada, Mexico, and the United States to certify that goods qualify for the preferential tariff treatment accorded by NAFTA. The Certificate of Origin must be completed by the exporter.

To avoid confusion, the CBP Form 434 will no longer be accepted for claims of preferential treatment under the USMCA. Even if the rule of

origin for the subject good is the same under NAFTA and USMCA and all of USMCA ' s required data elements are present on Form 434, the good needs to be recertified under USMCA.
