Wage and Hour Laws in Maryland. The federal Fair Labor Standards Act (FLSA) and Maryland law set the wage and hour standards employers must follow, including the minimum wage, overtime, and other wage protections. Employers

must pay the highest minimum wage applicable to employees, whether set by federal, state, or local law. Maryland's current minimum wage is \$10.10, which is higher than the federal rate of \$7.25.
