For domestic voyages, the pre-sea examination can be performed by a medical examiner of seafarers. Periodic examinations for domestic and international voyages are performed by medical examiners of seafarers. The Danish Maritime Authority may require a seafarer or fisherman holding a valid health certificate to undergo a new medical examination conducted by a medical practitioner or specialist appointed by the Danish Maritime Authority if, based on available information on health it is considered doubtful whether the seafarer or fisherman is still fit for his or her field of work on board.
