After sending the Landlord's Guarantor Rent Letter (14-Day Demand) to your tenant's guarantor, your tenant is still in rent arrears of three weeks. If rent is still due after 21 days, you can use this rent arrears demand letter to inform the guarantor that the tenant is still in rent arrears and confirm that you intend to take legal action against the guarantor if the rent is not paid.
