In contrast to the First Amendment of the United States Constitution, the 1789 Declaration of Human and Civic Rights provided limits to freedom of expression in its very definition. Article 10 declares that "[n]o one may be disturbed on account of his opinions, even religious ones, as long as the manifestation of such opinions does not interfere with the established Law and Order."

Freedom of press is there guaranteed under fundamental right to freedom of speech and expression but is under restriction of Public order, morality and public interest at large. So, media should work to broadcast right information to the people but it should not be judgmental itself.

"But freedom of expression is not without limits," added the Prime Minister. We don't have the right, for example, to cry "fire" in a crowded cinema; there are always limits. In a pluralistic, diverse and respectful society like ours, we must be aware of the impact of our words, of our actions on others, particularly these communities and populations who still experience enormous discrimination.

Prime Minister Justin Trudeau's response to Islamic terrorist attacks in France has attracted criticism after he said "freedom of expression is not without limits." Trudeau was commenting on a series of events that have rocked the French nation, after a French teacher was beheaded for showing his students a Charlie Hebdo cartoon which depicted the Prophet Mohammed.

When asked about the beheading in France, Trudeau responded that "freedom of expression is not without limits." He further compared drawing Muhammad to yelling "fire in a crowded movie theater," referencing a now-overturned US Supreme Court ruling which allowed the US government to imprison political dissidents who spoke against the military draft.
