Nations that score high for uncertainty avoidance include Greece, Portugal, Italy, Spain, Belgium, Poland, Japan, France, Argentina, Chile, Turkey and South Korea. Nations that score low for uncertainty avoidance, indicating they are comfortable with uncertainty , include Singapore, Denmark, Sweden, China, United Kingdom, India, Malaysia and the United States.
